## Reports:

Mayor David Roche: Comment as we go along.

#### **Fire Chief Marc Neumann:**

- COVID stats: as of Dec 4- 28,000---Cuyahoga County—664 deaths, 1,003 in 44143 AREA...in red alert status level 3, high risk of exposure and spread. (get #'s from him)
- Vaccine distribution—Dec 15<sup>th</sup> date to start. FDA final approval of Pfizer. Limited supply and only those in critical need. Vaccines to hospitals and Walgreens care centers.
- Moderna vaccine—pending FDA approval to hospitals and health depts. for front line workers.
- 2 vaccine regime and 2<sup>nd</sup> vaccine is done after 3 weeks. Accuracy of 2<sup>nd</sup> dose 95%. How precise does this have to be? (Ursu). Chief said unsure on how close the 3 week mark has to be.
- Moderna and Astrozenaca pending approval for the mass vaccination of public in spring/summer 2021.
- Lentine asked if there is a preference on vaccine company? Chief said they are all over 90% effective. Some more conducive to public distribution. The deep refrigeration need is difficult for many places.
- Squad update: Currently being repaired and coming back this week we hope. UH covering costs of repairs. UH donated a use of an ambulance to the city until then. Then will have to send other squad out for minor repair job on stretcher.
- No firefighters have COVID right now...all healthy. PPE has become part of our lifestyle. Have only had one case with a firefighter having it and it was a mild case/asymptomatic, and he was out for 14 days on quarantine.

## **Building Commissioner, Jim Urankar:**

Email from David Frank—secured ownership of the retention pond. Moving forward with approvals now.

### Finance Director, Jim Teknipp:

- Busy with open enrollment for medical insurance benefits.
- Analyzing YTD financial records, grant funding and end of year transfers.
- Looking into the CARES ACT grant expenditures that were received.
- Lisa Delassandro, Payroll, completed payroll for bargaining agreements and paid out.

Recreation Director, Rick Dula: -excused-

#### **Economic Development Director, Brian Gleisser:**

- Submitting \$150K CBDG grant due Dec 11<sup>th</sup>.
- Finance Committee--\$50K supplemental grant due in Jan
- Pre-con meeting for Lodge improvements today...met on this. Went over everything with architect and draft schedule presented—early May completion hopeful. Supply chain may be a challenge.

### **City Engineer, Lee Courtney:**

- Started restoration on west bound lanes from water main break. Concrete and asphalt going in soon.
- Trebisky—what's leaking (Alexander) there? Courtney said the water dept knows about it and has been there twice in the last week, but done nothing yet. Alexander said it seems really dangerous there and it could get icy as it gets colder.

#### **Service Director Don Kerniskey:**

- Kerniskey added that they are well aware of it and working on water main pipes in city. Mayor discussed
  the piping and the water main breaks. Outside of pipes deteriorating and causing problems. The Water
  Dept does maintain a great database on the breaks and costs.
- Leaf pickups- when snow melts down will be out there picking them up and will keep it up until they are can before snow hits again.
- Kudos to the men working on branches today on Heather Lane, picked up branches and trees in the area. Had a resident call to praise the work there.
- Henry added that the city cleaned up all the leaves on her tree lawn as well as her whole street. Very clean and impressive job.
