A Message from Mayor Daniel J. Ursu

Many of you enjoyed this past summer's Family Day Weekend and the "Spirit of Richmond Heights" Parade. The chief planner of the weekend was Recreation Director Teri Drda. As such Teri does a wonderful job working with many others to make the weekend a success year after year. The Parade is especially challenging to organize and I believe that you would be interested in knowing a bit more about it.

It begins with a well-experienced Parade Committee headed by Teri. This year it consisted of herself, Councilman at Large Dave Davies, my assistant Marilyn Wilson, Police Dispatcher Mary Delgado, and resident Kathy Pohlhammer. They meet as soon as the previous year's Parade is complete to begin planning for the following year. They analyze what went right and wrong in the previous Parade and use those lessons learned to make the next Parade even better.

During the year they meet to discuss what special attractions should be invited to participate in the Parade, keeping in mind the budget that has been appropriated, and begin to contact those parties to reserve them for the date of the Parade. The Committee contacts the property owners of the staging site to make sure there is no conflict with use of their property on the day of the Parade. They work with Police Chief Gene Rowe, Fire Chief Mike Cek and Service Director Don Lazar to help coordinate road closures on the day of the Parade. Letters are sent to businesses, institutions, and residents advising them of the upcoming traffic alterations. Signs are posted by the Service Department at all appropriate roadways.

When the date of the Parade is nearing, the Committee sends reporting assignments to all Parade participants to organize them sequentially for a timely arrival at the site. On the date of the Parade, Councilman Davies acts as site leader to make sure everybody steps off in the proper sequence and time.

As you could imagine, this is a tremendous amount of work, with numerous large and small details, and we are indeed fortunate to be blessed with such a competent and dedicated Parade Committee. Besides those mentioned above, instrumental in the Parade's success were Recreation Board Members Eloise Henry, Tony Hocevar, James Hopkins, Sookram Phalgoo, Lisa Taylor, and Terry Yerkic, members of the Police Department and the Police Auxiliary, School Transportation Supervisor Ruth Sanders and resident volunteer Joe Herchick. Highland Road/Richmond Road Intersection Business District

In July, City Council passed legislation designating the Richmond Road-Highland Road intersection as a Business District. Along with this designation is a reduction in the posted speed limit from 35 miles per hour to 25 miles per hour, consistent with State Law. The Business District is 800 feet on Richmond Road and 1000 feet on Highland Road. These distances include the intersection and the approaches to the intersection where businesses are located. The change was necessary due to the increased pedestrian traffic in the area, as well as an increase in traffic entering and exiting local businesses. One of the primary ingredients in auto accidents is speed. Excessive speed reduces driver reaction time and increases the severity of damage and injury.

The required signage has been posted in the area. A 30-day grace period was given to motorists to observe and adjust their driving habits to the changes. Enforcement of the new speed limit is now being observed.

PETS IN THE CITY PARKS

In October of 2003, as a result of the urging of some residents, the City declared a 90-day moratorium on the restriction of allowing pets in the park. During this 90-day period, residents could bring their pets in the park as long as the owners register the pet with the police department. The moratorium was declared in an attempt to evaluate what the results of allowing pets in the park would be.

There were no adverse incidents over this period of time and in July, the City eliminated the prohibition of pets in the park from the City Ordinance defining the "Park Regulations". Pets are allowed in the park, with the following restrictions:

- The owner and pet must be registered with the police department
- Pets may be walked in the park but must be leashed at all time and are only permitted in open park areas. They are not permitted in any other recreation facilities.
- All other City ordinances with respect to vicious animals and the removal of animal excrement must be obeyed.

A violation of this rule could result in a \$100 fine, removal from the park premises and suspension of pets in the park registration.

POLICE DEPARTMENT FACILITY

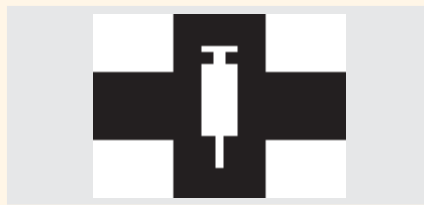
Each year the Ohio Association of Chiefs of Police conducts a seminar for agencies that are planning to build new police facilities or renovate older facilities. The purpose of these seminars is to provide police administrators with ideas for building functional facilities, as well as to provide them with an opportunity to question those police administrators who have already gone through the building process. Persons that attend this seminar come away with a much better idea of what to expect during their building process and are better equipped to deal with all of the complications as a result.

The new Richmond Heights Police Facility was honored by being chosen as one of the facilities that attendees would tour as part of this seminar. On October 26, over 30 law enforcement administrators from agencies throughout the State will tour the facility. After the tour, attendees will be provided with an opportunity to question Chief Rowe and Lt. Steffen about their experiences in the planning, building and equipping of the facility as well as the complications of moving from one facility to another without disrupting service.

Fats, oils and greases aren't just bad for your arteries; they are bad for your sewers too! Grease and oils from food preparation washed down the drain can cause sewer overflows and backups, an unhealthy environment, and bad odors.

HERE IS HOW YOU CAN HELP

Residential Homeowners:

- Never pour grease down sink drains or into toilets.
- Do not put grease or oil down garbage disposals.
- Scrape grease and food scraps from plates, pots, and grills into the trash for disposal.
- Pour used oil into jars with lids and dispose in the trash when filled.
- Dispose of food scraps and other solids in the trash instead of washing them down the drain.
- Report illegal dumping to your city service department.

FOR RESTAURANT AND BUSINESS OWNERS

- Use "Dry Clean-up" methods to prevent washing the waste down the drain.
- Avoid spills by training employees and emptying containers in a timely manner.
- Maintain your equipment to properly collect, filter and store fats, oils and greases.
- Ensure your grease traps are sized and maintained appropriately.

NEW WARD 3 COUNCILMAN

David H. Roche was elected to serve as Ward 3's City Council representative at the last General Election. Dave and his wife Aire have been Richmond Heights residents for 26 years and have been very active in the community participating in many City sponsored social activities. They are also members of the Heights Regional Chamber of Commerce. Dave was recently elected President of the local chapter of the National Association of Investors, Inc., an organization dedicated to investor education. Aire and Dave operate their own business that specializes in computer training and in adaptive equipment for people with disabilities.

Recently, Dave was recognized for completing requirements for certification by the Ohio Municipal League with certification by its Municipal Leadership Training Academy. "The graduates of the Municipal Leadership Training Academy have a better knowledge of the laws guiding municipal government in Ohio and are better equipped to make informed decisions that improve the quality of governance in their communities", according to Ohio Municipal League Executive Director Susan J. Cave.

THE BENEFITS OF OBTAINING A BUILDING PERMIT

The Building Department, in previous installments in the City Edition, has discussed the importance of building safety in the home. Two of the issues previously discussed were issues that affect your family 24 hours a day, seven days a week. They were:

1. The sound of safety; maintaining a properly operating smoke detector in your home.
2. Make a safe exit; prepare your home and your family to make an efficient emergency exit in case of an incident.

This installment will focus on the benefits of obtaining a building permit. A building permit gives a property owner the legal right to begin construction of a building project. If you are uncertain if you need a permit contact the Building Department. This will give you the opportunity to discuss with the Building Official the scope of your project and determine if a permit is necessary. Even if a permit is not required, the Building Official can answer construction questions and provide valuable advice.

Typically, most additions, alterations and basement remodeling, bath and kitchen renovations, accessory uses such as sheds, decks and fences and any electrical, plumbing, heating, air conditioning and ventilation work requires a permit. It will allow professionally trained and certified inspection personnel to conduct safety inspections for code compliance upon the work.

It is important to realize that your home is your investment. If your construction project does not comply with the building code the value of your investment could be reduced. Insurance companies may not cover work done without a permit or inspections. A property owner who can demonstrate that code requirements were met through Building Department records of permits and inspections will have a strong ally if something were to occur to trigger a lawsuit.

RICHMOND HEIGHTS MIDDLE SCHOOL 2004 - 2005 NEW SCHOOL YEAR SCHEDULE

Middle School students will begin the new school year with an 8:00 a.m. starting time and a 2:30 p.m. closing time. The new time is a development of the Principal's Advisory Council researching successful middle schools and adolescent characteristics.

The teacher day will begin with START time (Student, Teacher, Academic Reinforcement Time) from 7:20 a.m. - 8:00 a.m. This time will be used for professional staff development, staff meetings, teacher/parent intervention assistance meeting and departmental meetings.

All students, staff and administrators will engage in silent reading each morning from 8:15 a.m. - 8:30 a.m. Placing emphasis on reading everyday will help develop lifelong habits of reading for sheer pleasure. We hope to develop a reading library corner in every classroom.

Block scheduling will be implemented at the sixth grade level. Sixth graders will have double blocks of time for language arts, reading, math, science and social studies. Seventh and eighth graders will maintain single period classes rotating through a core team of teachers. Exploratory Spanish classes will be included at the 7th and 8th grade level. We will continue to offer Spanish 1 and Algebra 1 for high school credit for qualifying 8th graders. All middle school students will take computer technology, home economics, art, music and HPE classes on rotational bases.

With the Board of Education approving the new schedule for the fall, new excitement generated by students, staff and administration will produce a building climate fertile for increased academic achievement.

AT YOUR SERVICE DEPARTMENT

Another Summer Season is coming to an end, and the Service Department is preparing for (yes, kids) back to school. The Service Department recently completed street striping, and preparing all the school zones. They are also in the middle of a big drive replacing Street Signs, Stop Signs and posts.

The road crew had a busy season repairing the roads where there were a large number of water main breaks.. The landscaping crew repaired tree lawns from the long hard winter.

Service received numerous phone calls at the beginning of the season about mulch, and where it can be picked up. The City no longer has a mulch pile behind the Kiwanis Lodge. If you would like organic soil, you can contact The Greater Cleveland Ecology Association at (216) 687-1266. For a nominal fee you can purchase organic soil from them.

RECYCLING AT SERVICE GARAGE BENEFITS CITY

Richmond Heights is a member of the Cuyahoga County Solid Waste District's Paper Marketing Cooperative. Beginning in August, members of the Cooperative will receive \$40/per ton for mixed paper from Caraustar Recycling, a significant increase from the very low, and variable price the City has been getting. Also, Caraustar will now accept all forms of mixed paper. This includes newspapers, magazines, junk mail, cereal boxes and cardboard (please flatten the boxes if possible) and phone books. Most any form of paper is now recyclable, as long as it is not waxed or foil wrapped, is not in a plastic bag, and is dropped off in the container at the Service Garage. It is important to remember that the City of Richmond Heights saves money in a couple of ways. One would be the \$32/per ton the City would pay to have it hauled to the landfill. The other benefit is the City earns \$40/per ton from Caraustar.

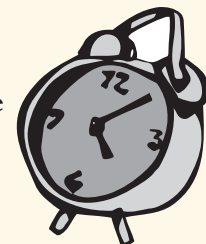
