Mt. Sinai Health Care Foundation Visits STC



STC welcomed board members from The Mt. Sinai Health Care Foundation for a site visit in October, 2019. The group inspected vehicles, toured the Call Center and together we discussed STC's goals. The Transit Connect that the foundation helped STC purchase in 2017 was on site for the tour.

STC was founded 14 years ago, when local transportation providers began exploring shared services. The Mt. Sinai Health Care Foundation commissioned a transportation study to analyze the impact of the access problem for seniors. The results established the STC model of partnership that reflects the needs and budgets of the contracting municipality or agency. The foundation remains an advocate for seniors and accessible transportation. It awarded another three-year operating grant to continue supporting STC's essential operations.

Dwayne Brake Represents Greater Cleveland Food Bank on STC Board

In July, STC welcomed its newest Board of Directors member, Dwayne Brake, appointed to the board by Cuyahoga County Executive Armond Budish. Dwayne is Vice President of Operations at Greater Cleveland Food Bank, where he has worked since 2010, after leadership roles in retail logistics and operations. He holds a B.S. in merchandising management from Michigan State University, along with certifications in Lean Six Sigma.

Dwayne is an expert in improving operations efficiencies and strategic planning. STC welcomes his business expertise, and representation from an organization that aligns with STC's mission. Many passengers rely upon STC to connect to a hot nutritious meal, pick up produce and staple products at their local senior center, or shop for groceries.

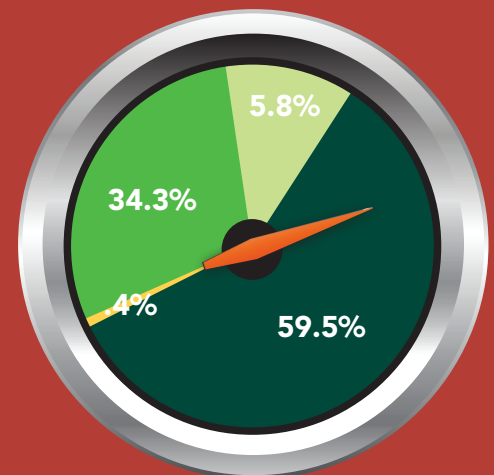
