

RESOLUTION NO. 77-2011

A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO A PURCHASE AGREEMENT THROUGH THE OHIO DEPARTMENT OF ADMINISTRATIVE SERVICES COOPERATIVE PURCHASING PROGRAM FOR SNOW PLOW AND DUMP TRUCK BODY EQUIPMENT FOR THE DEPARTMENT OF PUBLIC SERVICE.

WHEREAS, Council has authorized cooperative purchasing through the competitive bids obtained by the State of Ohio Department of Administrative Services Cooperative Purchasing Program; and

WHEREAS, the Director of Public Service has advised this Council that the City is in need of snow plow and dump truck body equipment to be installed on an existing truck chassis for snowplowing purposes and general use, the purchase of which can be made through the State of Ohio's Cooperative Purchasing Program; and

WHEREAS, Council's Finance Committee has reviewed the need for this proposed purchase and recommends the same and this Council desires to authorize the procurement of this equipment through the State Cooperative Purchasing Program from Concord Road Equipment Manufacturing, Inc.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Richmond Heights, State of Ohio, that:

Section 1: The Mayor is authorized to enter into a purchase agreement for certain snow plow and dump truck body equipment as set forth in the "Quote" attached hereto as "Exhibit A" from Concord Road Equipment Manufacturing, Inc. at a cost of \$27,929.97 under Schedule Contract No. 800116, as part of the State of Ohio's Cooperative Purchasing Program.

Section 2: The Finance Director is authorized and directed to appropriate to a proper account a sum sufficient to cover the costs of the purchase set forth in Section 1 above.

Section 3: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 4: This Resolution shall take effect and be in force from and after the earliest period allowed by law.


