RESOLUTION ACCEPTING A BID FROM SPANO BROTHERS CONSTRUCTION CO., INC. FOR THE REMOVAL, REPLACEMENT AND/OR LEVELING OF PUBLIC SIDEWALKS AND AUTHORIZING A CONTRACT THEREFOR AS PART OF THE 2010 ROAD PROGRAM.

WHEREAS, pursuant to legal notice therefor, duly published according to law, sealed bids were received at the office of the Clerk of Council of the City of Richmond Heights for labor and materials for removal, replacement and/or leveling of public sidewalks in the City pursuant to a comprehensive public sidewalk program that will be part of the City's 2010 Road Program and in accordance with specifications prepared by the City Engineer and on file in the office of the Clerk of Council; and

WHEREAS, pursuant thereto, the lowest and best bid received for said labor and materials for Sections I and II of the bid specifications was by Spano Brothers Construction Co., Inc.; and

WHEREAS, the City's public sidewalk program is designed so that the costs of the sidewalk removal, replacement and/or leveling will be borne by the abutting property owners and, as a general matter, it will be the abutting property owners who will contract directly with the contractor if an abutting property owner chooses to do so;

NOW, THEREFORE, Be It Resolved by the Council of the City of Richmond Heights, State of Ohio, that:

Section 1: The bid of Spano Brothers Construction Co., Inc. for Sections I and II of the City's bid specifications for labor and materials for the removal, replacement and/or leveling of the City's public sidewalks, being the lowest and best bid received for such labor and materials be, and the same is hereby, accepted and approved; and the Mayor is authorized and directed to execute and enter into on behalf of the City a proper contract for said labor and materials in accordance with the specifications prepared by the City Engineer.

Section 2: The City's 2010 Road Program is amended to include the public sidewalk program which is the subject of this bid acceptance.

Section 3: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in

compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 4: This Resolution shall take effect and be in force from and after the earliest period allowed by law.
