

ORDINANCE NO. 48-2010
INTRODUCED BY: ALEXANDER

AN ORDINANCE APPROVING THE CODIFICATION, EDITING AND INCLUSION OF CERTAIN ORDINANCES AS PARTS OF THE VARIOUS COMPONENT CODES OF THE CODIFIED ORDINANCES OF RICHMOND HEIGHTS, OHIO, AND APPROVING THE UPDATING OF VARIOUS SECTIONS OF THE TRAFFIC AND GENERAL OFFENSES CODES TO COMPLY WITH STATE LAW.

WHEREAS, various ordinances of a general and permanent nature have been passed which should be included in the Codified Ordinances of Richmond Heights, Ohio; and

WHEREAS, numerous sections in the current Traffic and General Offenses Codes need to be revised to reflect the current law in Ohio.

NOW, THEREFORE, Be It Ordained by the Council of the City of Richmond Heights, State of Ohio, that:

SECTION 1. This Council finds and determines that all formal actions of this Council concerning and relating to the passage of this ordinance were taken in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in those formal actions were in meetings open to the public in compliance with the law.

SECTION 5. This Ordinance shall take effect and be in force from and after the earliest period allowed by law.
