**Whereas** Mr. Dresser has been a valued citizen of Richmond Heights, Ohio since 1955 when he designed, built and moved into his Richmond Heights home with his wife Margaret "Peggy" and their young family; and

WHEREAS, Mr. Dresser is a graduate of The Ohio State University, and has been a licensed architect designing structures and advising on projects since the 1950's; and

WHEREAS, Mr. Dresser, working alongside then Mayor Richard St. John, established in 1970 the Architectural Review Board that still serves the citizens of Richmond Heights to this day; and

WHEREAS, Mr. Dresser, through the Architectural Review Board, has provided our community with may worthwhile and lasting contributions, including:

- The creation of high standards and crucial rules for home architectural designs within Richmond Heights; and
- The creation of rules requiring that commercial architectural designs and signage for buildings meet a high standard of quality relative to safety, functionality and beauty; and
- The dedication of almost 45 years of architectural oversight services to our community through the Architectural Review Board; and
- Pioneering the look and style of buildings and homes in Richmond Heights as it has grown into the beautiful community it is today.

WHEREAS, Mr. Dresser's outstanding service to Richmond Heights, Ohio reflects well upon himself and our community.
