

RESOLUTION NO.: 32-2015

A RESOLUTION EXPRESSING THE INTENT OF THE CITY OF RICHMOND HEIGHTS IN 2015 TO SELL BY INTERNET AUCTION PERSONAL PROPERTY REFERENCED IN OHIO REVISED CODE §721.15 WHICH IS NO LONGER NEEDED FOR PUBLIC USE OR ARE OBSOLETE OR UNFIT FOR THE USE FOR WHICH IT WAS ACQUIRED; AND DECLARING AN EMERGENCY.

WHEREAS, Ohio Revised Code (“O.R.C.”) §721.15 authorizes this Council to adopt a resolution to authorize the sale by internet auction of personal property, including motor vehicles, and other personal property equipment referenced in O.R.C. §721.15 which is no longer needed for public use or obsolete or unfit for the use for which it was acquired; and

WHEREAS, the auction will be conducted on-line by a vendor to be authorized by this Council and to do so in compliance with O.R.C. §721.15.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Richmond Heights, State of Ohio, that:

Section 1: This Council adopts this Resolution indicating its intent to sell unneeded, obsolete or unfit personal property by internet auction. The internet auction shall be conducted on-line by a vendor as an independent contractor to be authorized by this Council under terms and conditions to be determined by the Director of Public Service and the Mayor and, pursuant to O.R.C. §721.15, the number of days for bidding on the property shall be no less than fifteen (15) days.

Section 2: The Clerk of Council is authorized and directed to publish notice of this Resolution pursuant to O.R.C. §721.15 in a newspaper of general circulation in the City of Richmond Heights and by posting outside the offices of the Director of Finance.

Section 3: This Council further authorizes and directs the Clerk to publish a notice of this Resolution on the City’s website during the year 2015.

Section 4: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 5: This Resolution is declared to be an emergency measure immediately necessary to preserve the public health, safety and general welfare of the citizens of the City and for the further reason that it is immediately necessary to allow for the sale of unneeded City equipment at the earliest possible time; wherefore this Resolution shall be in full force and effect immediately upon its passage and approval by the Mayor.
