

RESOLUTION NO. 116 -2017
INTRODUCED BY: Mayor and Council

A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO A PURCHASE AGREEMENT WITH COUNTRYSIDE TRUCK SERVICE, INC. TO REPAIR THE ON-BOARD GENERATOR SYSTEM OF LADDER TRUCK 721 FOR THE DIVISION OF FIRE; AND DECLARING AN EMERGENCY.

WHEREAS, the Division of Fire's ladder truck 721 is out of service due to the need to replace its on-board generator system and Countryside Truck Service, Inc. has been providing factory authorized mechanical maintenance services for this ladder truck since it was purchased in 2000; and

WHEREAS, the Fire Chief has obtained a quote from Countryside Truck Service, Inc. for the emergency repair and replacement of the on-board hydraulic generator system of ladder truck 721 with a Workhorse 1061 remanufactured replacement generator unit at a cost not to exceed Six Thousand Nine Hundred Fifty Dollars (\$6,950.00); and

WHEREAS, this Council desires to authorize the Mayor to enter into purchase agreement with Countryside Truck Service, Inc. for the generator repair services described above.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Richmond Heights, State of Ohio, that:

Section 1: The Mayor is authorized to enter into an agreement with Countryside Truck Service, Inc. for the purchase and installation of a Workhorse 1061 remanufactured replacement generator unit on ladder truck 721 for a total cost not to exceed Six Thousand Nine Hundred Fifty Dollars (\$6,950.00).

Section 2: The Director of Finance is authorized to appropriate to a proper account the amount deemed necessary to cover the cost of the equipment.

Section 3: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.


Section 4: This Resolution is declared to be an emergency measure necessary for the preservation of the public health, safety and general welfare of the citizens of the City of Richmond Heights, and for the further reason that it is necessary to immediately purchase the equipment for use by the Division of Fire so that ladder truck 721 can be fully operational at the earliest time possible; wherefore, this Resolution shall be in full force and effect immediately upon its passage and approval by the Mayor.
