**A RESOLUTION AUTHORIZING THE MAYOR TO SUBMIT AN APPLICATION FROM THE CITY OF RICHMOND HEIGHTS FOR A PROJECT TO BE CONSIDERED BY THE CUYAHOGA COUNTY DEPARTMENT OF DEVELOPMENT FOR ITS COMMUNITY DEVELOPMENT SUPPLEMENTAL GRANT PROGRAM FOR FISCAL YEAR 2018, AUTHORIZING THE PAYMENT OF MATCHING FUNDS FROM THE CITY, AND DECLARING AN EMERGENCY.**

WHEREAS, the City has been advised by the Department of Development for the County of Cuyahoga that it is eligible to participate in a competitive application process for awarding of Community Development Supplemental Grant Program funds for Fiscal Year 2018;

WHEREAS, the City is permitted to submit one or more projects as part of its application, provided the aggregate total of the funding does not exceed \$50,000 for the Supplemental Grant Program;

WHEREAS, the grant requires the City to pay local matching funds and it is determined that an amount not to exceed \$10,000 will be adequate for that purpose and the City has confirmed that it can use its community cost-share funds under the Northeast Ohio Regional Sewer District's Regional Stormwater Management Program to pay the local match;

WHEREAS, a public hearing related to the City's participation in the Community Development Supplemental Grant Program for Fiscal Year 2018 was held by the City on November 21, 2017; and

WHEREAS, the Mayor and this Council determine to apply for the supplemental grant funds for the necessary public improvement project of installing a sanitary sewer line for the City's Greenwood Farm property that serves the public and to authorize the payment of required matching funds in an amount not to exceed \$10,000.

NOW, THEREFORE, Be It Resolved by the Council of the City of Richmond Heights, State of Ohio, that:

Section 1: The following project to enhance environmental conditions and to enhance the use of City public event facilities is designated as approved for inclusion in the application to be submitted by the City in response to the competitive application process undertaken by the Department of Development of Cuyahoga County for Community Development Supplemental Grant funds:

Installation of a sanitary sewer line from the public building used for public events at the City-owned Greenwood Farm in Richmond Heights in order for increased public use of that facility and for the environmental

reason of central conveyance and treatment of sanitary sewage from this public facility.


Section 2: The Mayor is authorized to submit the application for the aforesaid public improvement project on behalf of the City to the Department of Development of Cuyahoga County no later than November 30, 2017.

Section 3: If the grant is awarded to the City, the Director of Finance is directed to appropriate to a proper account the amount of \$10,000 as the required matching funds to accept the grant which sum shall come from the City's community cost-share funds under the Northeast Ohio Regional Sewer District's Regional Stormwater Management Program.

Section 4: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.


Section 5: This Resolution is an emergency measure immediately necessary for the preservation of the public peace, health, safety and general welfare of the citizens of the City of Richmond Heights by reason of the need to authorize submission of the application for Community Development Supplemental Grant funds for the necessary public improvement project set forth above by the impending deadline of November 30, 2017; and, therefore, shall take effect and be in force immediately upon its passage and approval by the Mayor.
