A RESOLUTION ACCEPTING THE BIDS FOR THE VARIOUS SECTIONS OF THE BID SPECIFICATIONS FOR REPAIRS AND RESURFACING OF VARIOUS CITY STREETS FOR THE 2018 ROAD PROGRAM AND AUTHORIZING CONTRACTS THEREFOR.

WHEREAS, pursuant to legal notice therefor, duly published according to law, sealed bids were received at the office of the Clerk of Council of the City of Richmond Heights for labor and materials for repairs and resurfacing of various City streets for the City's 2018 Road Program in accordance with specifications prepared by the City Engineer and on file in the office of the Clerk of Council; and

WHEREAS, pursuant thereto, the lowest and best bids received for said labor and materials for the various Sections of the Road Program bid specifications were:

SECTIONS 1 and 1A: C.A.Agresta Construction Co. .... \$220,974.00

SECTIONS 2, 2A, 3, and 3A: Specialized Construction, Inc. 101,409.00

TOTAL ..... \$322,383.00.

NOW, THEREFORE, Be It Resolved by the Council of the City of Richmond Heights, State of Ohio, that:

Section 1: The following bids in the total amount of \$322,383.00 for Sections 1, 1A, 2, 2A, 3 and 3A of the City's bid specifications for labor and materials for resurfacing repairs of various City streets for the 2018 City Road Program, being the lowest and best bids received for such labor and materials are accepted and approved; and the Mayor and Director of Finance the City are authorized and directed to execute and enter into on behalf of the City proper contracts for said labor and materials in accordance with the specifications prepared by the City Engineer as follows:

SECTIONS 1 and 1A: C.A. Agresta Construction Co. .... \$220,974.00

SECTIONS 2, 2A, 3, and 3A: Specialized Construction, Inc. \$101, 409.00

TOTAL ..... \$322,383.00.


Section 2: If necessary, the Director of Finance is authorized and directed to appropriate to a proper account a sum sufficient to cover the cost of said contracts.
