


# The City of Richmond Heights

## *A Resolution Bestowing the 2018 Public Safety Excellence Award Upon*

### *Jennifer Schultz, Assistant to the Chief of Police*

**Whereas**, Jennifer Schultz is the full-time assistant to the Richmond Heights Chief of Police and has held that position since June of 2009, having previously been a part-time City dispatcher from 2006 to 2008 and the Police Detective Bureau Secretary from 2008 to 2009;

WHEREAS, in addition to Ms. Schultz's substantial regular City duties, which include but are not limited to in-house record maintenance and data entry/clerical operations to include supervision of personnel records, she successfully handled the recent comprehensive transfer of City dispatch services to the regional Heights Hillcrest Communications Center;

WHEREAS, in October 2018, Ms. Schultz received a recognition letter from Casey Barrett of Security for the State's Law Enforcement Automated Data System ("LEADS") commending her for an outstanding job during a State LEADS inspection in 2018. Mr. Barrett stated in his letter, "All agencies should strive to model the LEADS technical inspections after Jennifer's example.";

WHEREAS, Ms. Schultz's is deserves major credit for the extremely smooth transition from the retirement of longstanding Police Chief Gene Rowe to the new Chief of Police, Thomas Wetzel, in November 2018.

NOW, THEREFORE, Be It Resolved by the Council of the City of Richmond Heights, State of Ohio, that:
