A RESOLUTION AUTHORIZING THE MAYOR TO PURCHASE FIRE HOSE FOR THE DIVISION OF FIRE.

WHEREAS, the Division of Fire has requested, and the Council's Safety Committee has recommended, the replacement of fire hose at a cost not to exceed \$5,000.00; and

WHEREAS, the required equipment is available from Finley Fire Equipment, Russell, Ohio.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Richmond Heights, State of Ohio, that:

Section 1: The Mayor is authorized to enter into an agreement with Finley Fire Equipment, of Russell, Ohio for the purchase of firefighting hose for the Division of Fire at a cost not to exceed \$5,000.00, in accordance with the quote from Finley Fire Equipment attached hereto as Exhibit "A."

Section 2: The Director of Finance is authorized to appropriate to a proper account the amount deemed necessary to cover the cost for the purchase of the equipment as set forth in Section 1 above.

Section 3: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 4: This Resolution shall take effect and be in force from and after the earliest period allowed by law.


