A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO A PURCHASE AGREEMENT WITH BEST EQUIPMENT FOR PRICING AT OR BELOW THE OHIO DEPARTMENT OF ADMINISTRATIVE SERVICES COOPERATIVE PURCHASING PROGRAM BID PRICING FOR ONE (1) LEAF MACHINE FOR THE DEPARTMENT OF PUBLIC SERVICE.

WHEREAS, this Council has previously authorized cooperative purchasing through the State of Ohio Department of Administrative Services Cooperative Purchasing Program and the purchase of equipment from vendors offering pricing at or below State Purchasing Program bid pricing;

WHEREAS, the Mayor and the Director of Public Service have advised this Council that the City is in need of one (1) New Trailer-Mounted Old Dominion Brush ("ODB") Leaf Machine for the Department of Public Service;

WHEREAS, the Director of Public Service has received a proposal from Best Equipment for one (1) New Trailer-Mounted ODB X-treme Vac LCT650 Debris Collector Leaf Machine for the amount of \$52,906.62, which is at or below the State Cooperative Purchasing Program price for Contract No. 041217-ODB;

WHEREAS, Council's Service and Recreation Committee has reviewed the need for this proposed purchase and recommends the same to Council;

WHEREAS, this Council desires to authorize the procurement of one (1) New Trailer-Mounted ODB X-treme Vac LCT650 Debris Collector Leaf Machine from Best Equipment for pricing that is at or below the State Cooperative Purchasing Program price, for an amount not to exceed \$52,906.62.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Richmond Heights, State of Ohio, that:

Section 1: The Mayor is authorized to enter into a purchase agreement with Best Equipment for the purchase of one (1) Leaf Machine, the description of which is more fully set forth in the preamble of this Resolution, for the Department of Public Service for a total cost not to exceed \$52,906.62.


Section 2: The Finance Director is authorized and directed to appropriate to a proper account a sum sufficient to cover the cost of said purchase agreement referred to in Section 1 above.

Section 3: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in

such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 4: This Resolution shall take effect and be in force from and after the earliest period allowed by law.
