A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO A PURCHASE AGREEMENT WITH GANLEY CHEVROLET OF AURORA, LLC FOR THREE (3) PATROL VEHICLES FOR USE BY THE DIVISION OF POLICE AND AT A COST AT OR BELOW THE OHIO DEPARTMENT OF ADMINISTRATIVE SERVICES COOPERATIVE PURCHASING PROGRAM BID PRICING.

WHEREAS, pursuant to the City Charter, Council has heretofore authorized cooperative purchasing through the State of Ohio Department of Administrative Services' Cooperative Purchase Program and purchases from vendors offering pricing at or below State Purchasing Program bid pricing;

WHEREAS, the Chief of Police has advised this Council that the Division of Police is in need of three (3) patrol vehicles and is recommending the purchase of 2021 model year Chevrolet Tahoes, 4WD (police conversion package);

WHEREAS, the Chief of Police has received a proposal from Ganley Chevrolet of Aurora, LLC for three (3) 2021 Chevrolet Tahoe 4WD vehicles for the total amount of \$114,012, which is at or below the State Cooperative Purchasing Program bid price for these 2021 Chevrolet Tahoes under State Contract Bid No. RS#900321, and the foregoing amount will be offset by the trade-in of two (2) used police vehicles (2017 Ford Explorer Interceptor SUV, VIN: 1FM5K8AR6HGD25780; and 2014 Ford Explorer Interceptor SUV VIN: 1FM5K8AR0EGA92054) which are no longer needed and unfit for municipal purposes in the amount of \$20,500;

WHEREAS, Council's Safety and Finance Committees have reviewed the need for this proposed purchase and recommends the same to Council;

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Richmond Heights, State of Ohio, that:

Section 1: The Mayor is authorized to enter into an agreement for the purchase of three (3) 2021 model year Chevrolet Tahoes, 4WD (police conversion package), from Ganley Chevrolet of Aurora, LLC at a cost not to exceed \$114,012, as set forth in the recitals to this Resolution.


Section 2. The purchase amount of \$114,012 in Section 1 of this Resolution will be offset by the crediting of \$20,500 to the City for the trading in of two (2) police vehicles no longer needed and unfit for municipal purposes.

Section 3: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal

action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 4: This Resolution shall take effect and be in force from and after the earliest period allowed by law.
