

**RESOLUTION NO.: 56 -2021**

**INTRODUCED BY: Mayor Roche and All of Council**

**A RESOLUTION AMENDING RESOLUTION NO. 53-2021 TO CORRECT THE TERMS OF OFFICE OF TWO APPOINTEES OF THE COUNCIL AS TRUSTEES TO THE BELLE OAKS NEW COMMUNITY AUTHORITY; AND DECLARING AN EMERGENCY.**

**WHEREAS**, pursuant to the authority to establish a new community authority set forth in Chapter 349 of the Ohio Revised Code, and this Council's Resolution No. 54-2020, and to appoint a certain number of trustees to the board of trustees of that new community authority, and pursuant to Resolution No. 53-2021 this Council re-appointed citizen members Timothy Lowe and Paul Ellis to the Board of Trustees of the Belle Oaks New Community Authority for one-year terms but the Ohio Revised Code provides for two-year terms for such trustees;

**WHEREAS**, the purpose of this Resolution is to correct the error in the terms of the two appointees, Timothy Lowe and Paul Ellis, to provide for two-year term appointments for each Trustee that will commence on June 16, 2021.

**NOW, THEREFORE**, Be It Resolved by the Council of the City of Richmond Heights, State of Ohio, that:

- Section 1: Resolution No. 53-2021 of this Council is corrected to authorize the re-appointment of current Belle Oaks New Community Authority Trustees Timothy Lowe and Paul Ellis as citizen- member appointees of this Council and that the term of office for each shall be for two years beginning June 16, 2021 and expiring at 11:59 p.m. on June 15, 2023.
- Section 2: All formal actions of this Council and any of its committees concerning and relating to the passage of this Resolution were taken in an open meeting of this Council, and that all deliberations of this Council were had in compliance with the law, including R.C. Section 121.22.
- Section 3: This Resolution is declared to be an emergency measure necessary for the immediate preservation of the public health, safety and welfare and for the further reason that the foregoing re-appointments must be made before the expiration of the appointees' current terms to ensure continuous representation by these Council appointees to the Belle Oaks New Community Authority for the stated two-year terms of office; wherefore, provided this Resolution receives the affirmative vote of two-thirds of the members of Council elected or appointed, it shall take effect immediately upon its passage and execution by the Mayor; otherwise it shall take effect and be in force from and after the earliest period allowed by law.
