**A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO A PURCHASE AGREEMENT WITH ATWELL'S POLICE AND FIRE EQUIPMENT CO. FOR THE PURCHASE OF NEW GUNS FOR THE DIVISION OF POLICE AND THE TRADE-IN OF OLD GUNS.**

WHEREAS, the Chief of Fire have advised this Council that the City is in need of thirty-one (31) new guns and accessories for the Division of Police;

WHEREAS, the Chief of Police has obtained a quotation from Atwell's Police and Fire Equipment Co. for the purchase of twenty-nine (29) new Glock handguns and accessories and two (2) new Rock River rifles for the gross price of \$21,807.00, with a trade-in credit of \$12,420.00 for the Division of Police's old guns, for a net cost of \$9,387.00, as set forth in the attached Exhibit "A."

WHEREAS, Council's Safety Committee has reviewed the need for this proposed purchase and recommends the same to Council;

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Richmond Heights, State of Ohio, that:

Section 1: The Mayor is authorized to enter into a purchase agreement with Atwell's Police and Fire Equipment Co. for the purchase of twenty-nine (29) new Glock handguns and accessories and two new Rock River rifles at a net cost not to exceed \$9,387.00, which includes the City's trade-in of older guns, all as set forth in Exhibit "A" to this Resolution.

Section 2: If necessary, the Director of Finance is authorized and directed to appropriate to a proper account a sum sufficient to cover the cost of said purchase agreement referred to in Section 1 above.

Section 3: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 4: This Resolution shall take effect and be in force from and after the earliest period allowed by law.
