

RESOLUTION NO.: 98 -2021

A RESOLUTION ACCEPTING THE AMOUNTS AND RATES AS DETERMINED BY THE BUDGET COMMISSION AND AUTHORIZING THE NECESSARY TAX LEVIES AND CERTIFYING THEM TO THE COUNTY FISCAL OFFICER; AND DECLARING AN EMERGENCY.

WHEREAS, this Council, in accordance with the provisions of law, has previously adopted alternative tax budget information for the next succeeding fiscal year commencing January 1, 2022; and

WHEREAS, the Budget Commission of Cuyahoga County, Ohio has certified its action thereon to this Council, together with an estimate by the County Fiscal Officer of the rate of each tax necessary to be levied by this Council, and what part thereof is without, and what part within, the ten-mill tax limitation.

NOW, THEREFORE, Be It Resolved by the Council of the City of Richmond Heights, State of Ohio, that:

Section 1: The amounts and rates, as determined by the Budget Commission in its certification, are hereby accepted.

Section 2: There is hereby levied on the tax duplicate of said City the rate of each tax necessary to be levied within and without the ten mill limitation as follows:

Section 3: The Clerk of this Council is authorized and directed to certify and forward a copy of this Resolution to the Fiscal Officer of Cuyahoga County prior to close of business on September 30. 2021.

Section 4: This Resolution is declared to be an emergency measure necessary for the immediate preservation of the public health, safety and general welfare of the City in that the City must file this Resolution with the County Fiscal Office at the earliest possible time to continue to receive the appropriate tax revenues necessary to operate the municipal government. Wherefore,


this Resolution shall take effect and be in force effective immediately, after its passage by Council and signature of the Mayor.
