A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO A PURCHASE AGREEMENT THROUGH OMNIA PARTNERS, PUBLIC SECTOR COOPERATIVE PURCHASING PROGRAM FOR THE PURCHASE AND INSTALLATION OF PLAYGROUND EQUIPMENT FOR DESAN PARK FROM PLAY & PARK STRUCTURES INC.

WHEREAS, the City applied for and received Community Development Supplemental Grant ("CDSG") funds in the amount of \$50,000 from Cuyahoga County for the public improvement of a new playground at DeSan Park;

WHEREAS, the City proposed the improvement at DeSan Park for an amount not to exceed \$80,000, leaving the City's local match portion at \$30,000;

WHEREAS, the City desires to purchase playground equipment through OMNIA Partners, Public Sector cooperative purchasing program from Play & Park Structures Inc. under OMNIA Partners Public Sector's Contract Number R170303 in an amount not to exceed \$74,349.19, using CDSG funds in the amount of \$50,000 and \$24,349.19 in City matching funds;

WHEREAS, this purchase through OMNIA Partners, Public Sector cooperative purchasing program without competitive bidding by the City is authorized by the City Charter;

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Richmond Heights, State of Ohio, that:

Section 1: The Mayor is authorized to enter into a purchase agreement with Play & Park Structures Inc. through OMNIA Partners, Public Sector cooperative purchasing program Contract Number R170303 for the purchase and installation of playground equipment at DeSan Park in an amount not to exceed ~~\$74,349.19~~, which will be offset by \$50,000 in CDSG grant funds.



Section 2: If necessary, the Finance Director is authorized and directed to appropriate to a proper account a sum sufficient to cover the cost of said purchase agreement referred to in Section 1 above.

Section 3: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 4: This Resolution shall take effect and be in force from and after the earliest period allowed by law.
