

RESOLUTION NO.: 116-2021

A RESOLUTION AUTHORIZING AN AMENDMENT TO THE TRANSPORTATION SERVICES CONTRACT WITH SENIOR TRANSPORTATION CONNECTION TO CONTINUE TO PROVIDE SENIOR CITIZEN AND DISABLED PERSON TRANSPORTATION IN THE CITY.

WHEREAS, on December 9, 2008, this Council adopted Resolution No. 104-2008, which authorized the Mayor to enter into an agreement with Senior Transportation Connection (“STC”), a non-profit corporation in Ohio, for a transportation van for senior citizens and disabled persons and to coordinate and schedule such transportation; and pursuant to this Council’s actions through passage of annual resolutions, it has extended and amended the original agreement with STC every year since its original approval of a contract in 2008;

WHEREAS, the City wishes to continue its cooperative services relationship with STC for the period of January 1, 2022 through December 31, 2022, for the provision of transportation to senior citizens and disabled persons and related services at the following rates:

Individual trips billed at \$24.00 per trip with a rider co-pay of \$4.00; and

Group trips (5 or more riders) are billed at \$10.00 per trip with a rider co-pay of \$1.00; and

Any rider who qualifies under Department of Senior and Adult Services eligibility is not expected to co-pay.

NOW, THEREFORE, Be It Resolved by the Council of the City of Richmond Heights, State of Ohio, that:

Section 1: The Mayor is authorized to enter into an amendment to the contract with Senior Transportation Connection, substantially in the form of the Fourth Amendment to Transportation Services Contract attached hereto as Exhibit “A” and as approved for legal form by the Director of Law, under the financial terms set forth in the recitals to this Resolution and for a term to run from January 1, 2022 through December 31, 2022, for certain services related to the provision of transportation for senior citizens and disabled persons.

Section 2: If necessary, the Director of Finance is authorized and directed to appropriate to a proper account the sum sufficient to cover the costs of the contract authorized in Section 1 of this Resolution.

Section 3: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal

action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.


Section 4: This Resolution shall take effect and be in force from and after the earliest period allowed by law.

**Fourth Amendment to Transportation Services Contract  
City of Richmond Heights and Senior Transportation Connection**

1. This amendment (the "Amendment") is made by the City of Richmond Heights and Senior Transportation Connection, parties to the agreement Transportation Services Contract dated February 14, 2019 (the "Contract".)

The contract is amended as follows:

1. Term: This amendment is effective January 1, 2022 through December 31, 2022.
2. Rates: Individual Trips are billed at \$24.00 per trip with a rider co-pay of \$4.00  
Group trips (5 or more riders) are billed at \$10.00 per trip with a rider co-pay of \$1.00  
Any rider who qualifies under Department of Senior and Adult Services eligibility is not expected to co-pay
3. Except as set forth in this Amendment, the Contract is unaffected and shall continue in full force and effect in accordance with its terms. If there is a conflict between this amendment and the Contract or any earlier amendment, the terms of this amendment will prevail.
