

**RESOLUTION NO.:** 8 -2022  
**INTRODUCED BY:** Mayor Thomas

A RESOLUTION EXPRESSING THE INTENT OF THE CITY OF RICHMOND HEIGHTS IN 2022 TO SELL BY INTERNET AUCTION PERSONAL PROPERTY, INCLUDING MOTOR VEHICLES AND OTHER PROPERTY REFERENCED IN REVISED CODE §721.15 WHICH ARE NO LONGER NEEDED FOR PUBLIC USE, OR ARE OBSOLETE OR UNFIT FOR THE USE FOR WHICH THEY WERE ACQUIRED; AUTHORIZING GOVDEALS.COM, INC. TO PERFORM THE SALES; AND DECLARING AN EMERGENCY.

WHEREAS, Ohio Revised Code §721.15 authorizes this Council to adopt a resolution on an annual basis to authorize the sale by internet auction of personal property owned by the City, including motor vehicles, and other personal property equipment referenced in §721.15 which are no longer needed for public use or obsolete or unfit for the use for which they were acquired;

WHEREAS, this Council wishes to adopt such a Resolution expressing its intent to sell such property by internet auction;

WHEREAS, this Council wishes to authorize the Mayor to enter into an agreement with GovDeals.com, Inc. to conduct such internet auctions;

WHEREAS, this Council wishes to authorize the Clerk to advertise in a newspaper of general circulation a notice of intent to sell unneeded, obsolete or unfit municipal personal property by internet auction;

WHEREAS, this Council further wishes to authorize the Clerk to post notice of the intent to sell unneeded, obsolete or unfit municipal personal property on the City's website throughout the year 2022, as needed;

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Richmond Heights, State of Ohio, that:

Section 1: This Council adopts this Resolution for the purpose of expressing its intent to sell unneeded, obsolete or unfit personal property by internet auctions. The internet auctions shall be conducted by GovDeals.com, Inc. Pursuant to Ohio Revised Code §721.15, the number of days for bidding on the property shall be no less than fifteen (15) days.


Section 2: Pursuant to Ohio Revised Code §721.15, the Clerk of Council is authorized and directed to publish notice of this Resolution in a newspaper of general circulation in the City.

Section 3: This Council further authorizes and directs the Clerk to publish a notice of this Resolution on the City's website during the year 2022.


