

RESOLUTION NO.: 10-2022

A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO AN ADDITIONAL SERVICES AGREEMENT WITH FLOCK GROUP INC. FOR THE PROVISION OF TWO ADDITIONAL LICENSE PLATE READING CAMERAS FOR THE DIVISION OF POLICE.

WHEREAS, pursuant to Resolution No. 25-2021, passed May 11, 2021, the City previously entered into an agreement with Flock Group Inc. for the provision of two (2) license plate reading camera and annual subscription services for a period of one (1) year for a total cost of \$5,500.00;

WHEREAS, the Chief of Police has advised this Council that the Division of Police wishes to have two (2) additional license plate reading cameras for needed law enforcement purposes;

WHEREAS, the Chief of Police has obtained a proposal, dated January 17, 2022, from Flock Group Inc. to provide two (2) additional license plate reading cameras at a cost of \$5,500.00 under the same terms and conditions as the existing agreement with Flock Group Inc. executed by the Mayor on May 19, 2021, but for the one (1)-year lease term to begin upon installation of the two (2) additional cameras and assurance of their efficient operation;

WHEREAS, Council's Safety Committee has reviewed the need for this proposed purchase and recommends the same to Council as a whole, and Council desires to authorize the lease of two (2) additional license plate reading cameras from Flock Group Inc. under the same terms and conditions as the existing agreement for an amount not to exceed \$5,500.00 for a one (1)-year term;

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Richmond Heights, State of Ohio, that:

Section 1: The Mayor is authorized to enter into an additional services agreement with Flock Group Inc. for the lease of two (2) additional license plate reading cameras substantially in the form of the Additional Services Agreement which incorporates the terms and conditions of the existing agreement with Flock Group, Inc. on file with the Clerk of Council, for an additional amount not to exceed \$5,500.00 but with the a one (1)-year term of the lease to commence upon the installation and assurance of efficient operation of the two (2) cameras;


Section 2: If necessary, the Director of Finance is authorized and directed to appropriate to a proper account a sum sufficient to cover the cost of the purchase in Section 1 above.

Section 3: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in


such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
