

RESOLUTION NO.: 93- 2022

A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO AN AGREEMENT WITH COLLINS EQUIPMENT CORP. FOR THE PURCHASE AND INSTALLATION OF ONE NEW PETRO VEND 200 FUEL ISLAND TERMINAL AND ASSOCIATED SOFTWARE, TRAINING AND ACCESSORIES FOR THE DEPARTMENT OF PUBLIC SERVICE.

WHEREAS, the Mayor and Director of Finance have advised this Council that the Department of Public Service is in need of one new Petro Vend 200 Fuel Island Terminal and associated software, training and accessories, including installation;

WHEREAS, the Director of Finance has received a quotation from Collins Equipment Corp., 3005 East 55th Street, Cleveland, OH 44127 for the provision and installation of one new Petro Vend 200 Fuel Island Terminal and associated software, training and accessories with extended warranty for the cost of \$20,494.40 and an annual hosting/update cost of \$900 per year;

WHEREAS, Council's Committees have reviewed the need for this purchase and recommend the same to Council with the funds coming from the City's "Local Fiscal Recovery Fund" that this Council created to deposit the American Rescue Plan Act of 2021 (ARPA) funds.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Richmond Heights, State of Ohio, that:

Section 1: The Mayor is authorized to enter into a purchase agreement with Collins Equipment Corp., 3005 East 55th Street, Cleveland, OH 44127 for the provision and installation of one new Petro Vend 200 Fuel Island Terminal and associated software, training and accessories for the cost of \$20,494.40, as set forth in the sales quote attached hereto as Exhibit A, for a total cost not to exceed \$20,494.40, utilizing funds from the Local Fiscal Recovery Fund, and an annual hosting/update cost of \$900 per year, provided the annual cost is appropriated by this Council on a yearly basis.





Installation

We will discuss with your IT personnel and review the necessary steps for the Phoenix cloud software installation and obtain a static IP, subnet, and gateway address from them for the new site controller. After the Phoenix Cloud login credentials are established for users, we will connect to the new FSC 3000 site controller and migrate the existing user file from the K800 site controller to the new FSC 3000. After the site controller is configured, remove and replace the K800 with new PV 200 FIT and test the system for proper operation. We will coordinate the system change over so there will be minimal down time at the fuel island.

If any additional time is necessary due to network issues or IT complications, it will be invoiced at our normal service labor and travel rates.
