INTRODUCED BY: Mayor Thomas

A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO A PURCHASE AGREEMENT WITH CONCORD ROAD EQUIPMENT MFG. FOR SERVICES TO INSTALL AN ICE CONTROL EQUIPMENT PACKAGE ON A CITY OWNED DUMP BODY AND CHASSIS FOR THE DEPARTMENT OF PUBLIC SERVICE.

WHEREAS, this Council has previously authorized cooperative purchasing through the State of Ohio Department of Administrative Services Cooperative Purchasing Program and the purchase of equipment from vendors offering pricing at or below State Purchasing Program bid pricing;

WHEREAS, the Mayor and the Director of Public Service have advised this Council that the City is in need of services for one (1) ice control equipment package to be removed from an older City truck and installed on a new truck purchased last year for the Department of Public Service;

WHEREAS, the Department of Public Service has received a proposal from Concord Road Equipment Mfg. for the aforementioned services for the amount of \$37,416.82, which is at or below the State Cooperative Purchasing Program price for State Contract No. 800860 for truck mounted spreaders for aggregate and ice control material;

WHEREAS, Council's Committees have reviewed the need for this purchase and recommend the same to Council with the funds coming from the City's "Local Fiscal Recovery Fund" that this Council created to deposit the American Rescue Plan Act of 2021 (ARPA) funds.

WHEREAS, this Council desires to authorize the procurement of services from Concord Road Equipment Mfg. for the removal, repurposing, and installation of the ice control equipment package from an existing City-owned truck body to a new truck purchased last year for the Department of Public Service at pricing that is at or below the State Cooperative Purchasing Program price, for an amount not to exceed \$37,416.82.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Richmond Heights, State of Ohio, that:

Section 1: The Mayor is authorized to enter into a purchase agreement with Concord Road Equipment Mfg. for services to remove, repurpose and install one (1) ice control equipment package from an older City truck to a newly purchased City truck, as set forth in Quote No. 73812, attached hereto as Exhibit A, utilizing funds from the Local Fiscal Recovery Fund, for the Department of Public Service for a total cost not to exceed \$37,416.82.




Section 4: This Resolution shall take effect and be in force from and after the earliest period allowed by law.


