

RESOLUTION NO.: 95 - 2020
INTRODUCED BY: Council President Cotton-Henry

A RESOLUTION AUTHORIZING AN AGREEMENT WITH PC ALTERNATIVES, LLC FOR ADDITIONAL INFORMATION TECHNOLOGY SUPPORT SERVICES FOR THE CITY.

WHEREAS, pursuant to Resolution No. 40-2020, adopted by this Council on April 14, 2020, this Council authorized, pursuant to a request for proposals, a contract with PC Alternatives, LLC for standard information technology ("IT") services for calendar year 2020 in an amount not to exceed \$6,000;

WHEREAS, this Council finds that additional IT services are needed in order to adequately protect and secure important City information that is communicated and stored electronically;

WHEREAS, PC Alternatives has served the City's information technology, video recording and telecommunications needs for several years, has provided reliable service and is familiar with the City's IT equipment;

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Richmond Heights, State of Ohio, that:


Section 1: The Mayor is authorized to enter into a contract with PC Alternatives, LLC for additional information technology support services for a term of one year to commence as of October 1, 2020, and continue through September 30, 2021, as set forth in the attached list of services and costs which is fully incorporated by reference into this Resolution and which shall not exceed \$ 25,000.

Section 2: To the extent it is necessary, the Director of Finance is authorized to appropriate to a proper account a sum sufficient to cover the costs of the agreement authorized in Section 1 of this Resolution.

Section 3: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 4: This Resolution shall take effect and be in force from and after the earliest period allowed by law.

Strategic action plan (With your consent, we will execute these actions under our current maintenance agreement.)

1. Systems/Network Security

- We will install and configure anti-malware\anti-virus software on the server, workstations and laptops. We'll include a proactive interface that will allow intrusion monitoring and firewall management. Passwords and PIN numbers will be managed and updated regularly on all of your computers, including mobile devices. We can discuss frequency. Network and data security is always of utmost important to us. We will provide you with reliable, trustworthy data and system security.

2. Data Security

- We will continue our dependable, triple-redundant backup plan that allows us to archive and verify data integrity before there is a loss. (we use on-site and cloud storage) We will continue to monitor your daily backups and alert you whenever we detect a problem at city hall. We will also review with you our simple disaster recovery plan and preventative data maintenance. This plan is inexpensive and easy to manage.

3. Systems Management

- Our goal here is to establish a fast and efficient computer network. That includes replacing your current MS Office software version and upgrading to professional business class version. In addition, we recommend data policy changes regarding IT equipment and system software/hardware audits. We can greatly assist you in your effort to move towards a secure and high performance operation. We will standardize access to the city server and create a uniform approach to data retrieval and synchronization on your mobile devices.

Configuring Council Chambers video recording (We will provide this fix as part of our existing service agreement)

- We can setup the audio/video to both record to YouTube and stream live via Zoom.
- We will live stream a Zoom Meeting using most of the current equipment. This allows council members to join the meeting via Zoom while also streaming it via YouTube. During the live event, there will be an approximate 20-second delay between the actual Zoom Meeting and the Live stream.
