

RESOLUTION NO.: 126 - 2020
INTRODUCED BY: Mayor and All of Council

A RESOLUTION ACCEPTING THE FINDINGS AND RECOMMENDATIONS OF THE FACT-FINDER IN CASE NO. 2018-MED-08-0719 (LABORERS LOCAL 860, LABORERS INTERNATIONAL UNION OF NORTH AMERICA); AND DECLARING AN EMERGENCY.

WHEREAS, the City of Richmond Heights has received the findings and recommendations of the fact-finder, Nels E. Nelson, in the Matter of Fact-Finding between the City and Laborers Local 860, Laborers International Union of North America ("Local 860"), State Employment Relations Board Case No. 2018-MED-08-0719, dated December 18, 2020;

WHEREAS, this Council has reviewed the findings and recommendations and has determined to accept them and to authorize the Mayor to execute a new collective bargaining agreement with Local 860 based on the issues collective bargained with Local 860 and which incorporates the provisions recommended by the fact-finder;

NOW, THEREFORE, Be it Resolved by the Council of the City of Richmond Heights, State of Ohio, that:


Section 1: This Council hereby accepts the findings and recommendation of the fact-finder in the matter set forth in the preamble to this Resolution.

Section 2: The Mayor is authorized to execute on behalf of the City a collective bargaining agreement with Local 860 based on the issues collective bargained with Local 860 and which incorporates the recommendations of the fact-finder in the matter set forth in the preamble to this Resolution.

Section 3: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.


