

RESOLUTION NO.: 48-2023
INTRODUCED BY: Lentine

A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO AN AGREEMENT WITH CHAGRIN VALLEY DISPATCH FOR THE PURCHASE OF NINE (9) PORTABLE RADIOS AND ONE (1) MOBILE RADIO FOR THE DIVISION OF FIRE.

WHEREAS, the Chief of Fire has advised this Council that the Division of Fire is in need of nine (9) portable radios and one (1) mobile radio to replace the current outdated inventory, the purchase and installation of which can be made from Chagrin Valley Dispatch, utilizing the State of Ohio Department of Administrative Services Cooperative Purchasing Program;

WHEREAS, the Charter permits, and Council has authorized, cooperative purchasing through the competitive bids obtained by the State of Ohio Department of Administrative Services Cooperative Purchasing Program;

Whereas, Council's Safety Committee has reviewed the need for the radio equipment and recommended the purchase and installation thereof from Chagrin Valley Dispatch for the amount of \$42,447.60 and the City administration recommends a 10% contingency allowance to that amount in the event there are unforeseen cost increases or additional accessories that are required during the installation of necessary equipment therefor for a total of \$46,692.00.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Richmond Heights, State of Ohio, that:

Section 1: The Mayor is authorized to enter into an agreement with Chagrin Valley Dispatch through the Ohio Cooperative Purchasing Program for the purchase and installation of nine (9) portable radios and one (1) mobile radio, for the Division of Fire for the price of \$42,447.60, as set forth in the attached quotation, with a 10% contingency allowance, for a total cost not to exceed \$46,692.00.


Section 2: The Director of Finance is authorized to appropriate to a proper account the amount deemed necessary to cover the cost for the purchase of the equipment as set forth in Section 1 above.

Section 3: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 4: This Resolution shall take effect and be in force from and after the earliest period allowed by law.
