A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO A PURCHASE AGREEMENT WITH NORTHCOST SIGNWORKS FOR THE PURCHASE OF NEW MASONRY SIGN PILLARS

WHEREAS, the Director of Public Service has advised that the City requires, and has received a quote from Northcoast Signworks of Bedford Heights, Ohio, for four (4) new masonry sign pillars with limestone collars and caps for the City, as set forth in the quote attached hereto as "Exhibit A".

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Richmond Heights, State of Ohio, that:

Section 1: The Mayor is authorized to enter into a purchase agreement with Northcoast Signworks for the purchase of four (4) new masonry sign pillars with limestone collars and caps, as set forth in the quote attached hereto as "Exhibit A", at a cost not to exceed \$10,470.00.

Section 2: The Finance Director is authorized to utilize the ARPA Fund for the cost of the purchase agreement authorized in Section 1.

Section 3. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 4: This Resolution shall take effect and be in force from and after the earliest period allowed by law.


