A RESOLUTION AUTHORIZING THE SALE OF ITEMS OF SPECIFIC
PERSONAL PROPERTY WHICH ARE NO LONGER NEEDED FOR
PUBLIC USE BY INTERNET AUCTION BY GOVDEALS.COM, INC.

WHEREAS, Ohio Revised Code § 721.15 authorizes this Council to adopt a resolution on an annual basis to authorize the sale by internet auction of personal property owned by the City, including motor vehicles, and other personal property equipment referenced in § 721.15 which are no longer needed for public use or obsolete or unfit for the use for which they were acquired, and Council adopted Resolution No. 31-2023 on February 28, 2023 to authorize internet auction sales during 2023, as required by R.C. § 721.15;

WHEREAS, the Director of Public Service has requested to sell specific personal property items that are unneeded, obsolete and /or unfit for the use for which they were acquired, through internet auction to be administered by GovDeals.com, Inc.;

WHEREAS, this Council wishes to authorize the sale of the items of personal property of the City that are listed in Exhibit A to this Resolution which are not needed for public use or are obsolete or unfit for the use for which they were acquired and to do so on GovDeals.com.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Richmond Heights, State of Ohio, that:


Section 1: The items of personal property listed in Exhibit A to this Ordinance are hereby determined to be unneeded for public use, and/or are obsolete or unfit for the use for which they were acquired and may be sold through internet auction by GovDeals.com, Inc.

Section 2: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 3: This Resolution shall take effect from and after the earliest period allowed by law.
