A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO A CONTRACT WITH THE C.A. AGRESTA CONSTRUCTION CO. FOR EMERGENCY WATERMAIN BREAK PAVEMENT REPAIRS TO RICHMOND ROAD.

WHEREAS, there were two watermain breaks in Richmond Road which were repaired by the Cleveland Water Department in 2022, one at the intersection of Richmond and Highland Roads and one on Richmond Road near the Cuyahoga County Airport, north of the school drives, which required extensive emergency pavement repair following the excavations and watermain repairs;

WHEREAS, due to the urgency of performing the pavement repairs, the Director of Public Service and Properties at that time requested that the work be performed by C.A. Agresta Construction Co., which was immediately available since it was already performing road repairs in the City as a subcontractor to Specialized Construction under the 2022 Road Program contract with the City;

WHEREAS, the two pavement repairs were completed in June of 2022, and C.A. Agresta Construction Co. submitted an invoice in the amount of \$30,498.60 for the two (2) Richmond Road watermain repairs;

WHEREAS, pursuant to Section VI-3 of the Charter of Richmond Heights, this Council may authorize a contract involving an expenditure of more than twenty-five thousand dollars without advertising for bids if it determines and declares by an affirmative vote of not less than five (5) members that an emergency exists and sets forth the nature of the emergency in its resolution or ordinance.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Richmond Heights, State of Ohio, that:

Section 1: This Council determines and declares that an emergency existed in 2022 following the two watermain breaks in Richmond Road, one at the intersection of Richmond and Highland Roads and one on Richmond Road near the Cuyahoga County Airport, north of the School District's driveways, requiring urgent pavement repairs by C.A. Agresta Construction Co. to alleviate the adverse and unsafe impacts on vehicular traffic and persons caused by the excavations.

Section 2: The Mayor is authorized to enter into a contract with C.A. Agresta Construction Co. for the emergency pavement repairs set forth in Section 1 of this Resolution in the amount of Thirty Thousand Four Hundred Ninety-Eight Dollars and Sixty Cents (\$30,498.60).


Section 3: The Finance Director is authorized to appropriate funds from Fund No. 410 for the cost of the contract authorized in Section 2.

Section 4: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 5: This Resolution shall take effect and be in force from and after the earliest period allowed by law.
