**A RESOLUTION CERTIFYING CERTAIN COSTS AND FEES OF THE CITY OF RICHMOND HEIGHTS FOR THE COLLECTION AND DISPOSAL OF SOLID WASTE SERVICES AT CERTAIN RESIDENTIAL DWELLINGS WITHIN THE CITY TO THE COUNTY FISCAL OFFICER FOR PLACEMENT ON THE TAX DUPLICATE AND FOR COLLECTION; AND DECLARING AN EMERGENCY.**

WHEREAS, the Department of Finance has reported to Council the estimated total costs and projected fees for the collection and disposal of garbage, rubbish, and refuse for certain residential dwellings in the City for calendar year 2024, in accordance with Section 951.07(a)(2) of the Codified Ordinances of the City of Richmond Heights, Ohio;

WHEREAS, Council desires to certify said costs and fees for collection and disposal of residential solid waste services to the Cuyahoga County Fiscal Officer for placement on the tax duplicate of the applicable parcels of land and for collection as other taxes.

NOW, THEREFORE, Be It Resolved by the Council of the City of Richmond Heights, State of Ohio, that:

Section 1: The costs and fees listed in Attachment "A" hereto, which is made a part hereof for all purposes, for the collection and disposal of solid waste services for calendar year 2024 are hereby certified to the Cuyahoga County Fiscal Officer for the purpose of making the same a lien upon the parcels and lots set forth in Attachment "A", located in the City of Richmond Heights, Cuyahoga County, Ohio, to be collected as are other taxes and returned to the General Fund of the City of Richmond Heights pursuant to Section 951.07(a)(2) of the Codified Ordinances of the City of Richmond Heights.


Section 2: The Clerk of Council and the Director of Finance are authorized to prepare and submit all necessary documents to accomplish the required written return to the County Fiscal Officer on or before September 11, 2023.

Section 3: This Resolution is declared to be an emergency measure immediately necessary for the preservation of the public peace, health, safety and welfare of the citizens of the City of Richmond Heights for the reason of the necessity to certify said costs and fees to the Cuyahoga County Fiscal Officer by the deadline for doing so of September 11, 2023; and, therefore, shall take effect and be in force immediately upon its passage and approval by the Mayor.
