

RESOLUTION NO.: - 158 -2023

A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO A PURCHASE AGREEMENT WITH MONTROSE FORD FOR THE PURCHASE OF TWO (2) 2023 FORD EXPLORER POLICE INTERCEPTORS FOR A LOWER PRICE THAN PRICING AVAILABLE UNDER THE OHIO COOPERATIVE PURCHASING PROGRAM.

WHEREAS, pursuant to the City Charter, Council has heretofore authorized cooperative purchasing through the State of Ohio Department of Administrative Services ("DAS") Cooperative Purchasing Program;

WHEREAS, pursuant to state law, political subdivisions may purchase from other vendors upon equivalent terms, conditions, and specifications, but at a lower price than pricing under the current DAS Cooperative Purchasing Program contracts;

WHEREAS, the City has received a quote from Montrose Ford for two (2) 2023 Ford Explorer Police Interceptors for a lower price than the pricing under the current DAS Cooperative Purchasing Program contract, as set forth in the quote attached hereto as "Exhibit A";

NOW, THEREFORE, Be It Resolved by the Council of the City of Richmond Heights, State of Ohio, that:

Section 1: The Mayor is authorized to enter into an agreement with Montrose Ford for the purchase of two (2) 2023 Ford Explorer Police Interceptors, as set forth in the quote attached hereto as "Exhibit A", at a cost not to exceed \$88,590.22.

Section 2: The Director of Finance is authorized to appropriate funds from Fund # 401-7150-54650 for the cost of the agreement authorized in Section 1.




Section 4: This Resolution shall take effect and be in force from and after the earliest period allowed by law.
