A RESOLUTION AUTHORIZING THE SALE OF UNNEEDED ITEMS OF
SPECIFIC PERSONAL PROPERTY OF THE CITY OF RICHMOND HEIGHTS
THROUGH AN INTERNET AUCTION BY GOVDEALS.COM, INC.

WHEREAS, Ohio Revised Code § 721.15 authorizes this Council to adopt a resolution to authorize the sale by internet auction of personal property owned by the City, including personal property items referenced in R.C. § 721.15, which are no longer needed for public use or are obsolete or unfit for the use for which they were acquired, and this Council adopted Resolution No. 31-2023, on February 28, 2023 to authorize internet auction sales during 2023, as required by R.C. § 721.15;

WHEREAS, the Division of Police has requested to sell certain vehicles that are unneeded, obsolete and/or unfit for the use for which they were acquired, through an internet auction to be administered by GovDeals.com, Inc;

WHEREAS, at this time, this Council wishes to authorize the sale of the vehicles that are listed in Exhibit A to this Resolution which this Council finds are not needed for public use, and/or are obsolete and/or unfit for the use for which they were acquired.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Richmond Heights, State of Ohio, that:

Section 1: The vehicles and items of personal property listed in Exhibit A to this Resolution are determined not to be needed for public use, and/or are obsolete or unfit for the use for which they were acquired and may be sold through an internet auction procedure by GovDeals.com, Inc.

Section 2: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 3: This Resolution shall take effect and be in force immediately upon its passage and approval by the Mayor.




