

RESOLUTION NO. 164 -2023

A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO A PURCHASE AGREEMENT WITH MUNICIPAL EMERGENCY SERVICES FOR THE PURCHASE OF TWENTY-ONE (21) CRITICAL COVERAGE HOODS AND FORTY-TWO (42) PAIRS OF FIREFIGHTER FLAME GLOVES FOR THE DIVISION OF FIRE AND UTILIZING OHIO BUREAU OF WORKERS' COMPENSATION FIREFIGHTER EXPOSURE TO ENVIRONMENTAL ELEMENTS GRANT FUNDS.

WHEREAS, the Division of Fire has requested, and the Council's Safety Committee has recommended the purchase of 21 BarriAire Gold Critical Coverage Hoods and 42 pairs of Gauntlet Cuff Firefighter Flame Gloves at a cost not to exceed Seven Thousand One Hundred Ninety Dollars (\$7,190.00);

WHEREAS, the City has received an Ohio Bureau of Workers' Compensation "Firefighter Exposure to Environmental Elements Grant" in the total amount of \$11,386.59 for this purchase, which requires a match by the City in the amount of \$2,277.32;

WHEREAS, the required equipment is available from Municipal Emergency Services of Minneapolis, Minnesota and the City will be required to pay the entire amount for the items and will be reimbursed in the amount of \$5,991.67 from the grant funds.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Richmond Heights, State of Ohio, that:


Section 1: The Mayor is authorized to enter into an agreement with Municipal Emergency Services for the purchase of 21 BarriAire Gold Critical Coverage Hoods and 42 pairs of Gauntlet Cuff Firefighter Flame Gloves at a cost not to exceed \$7,190.00, as set forth in the attached quotation, and the Chief of Fire and Director of Finance shall be authorized to take all actions required to obtain the reimbursement to the City of \$5,991.67 of this purchase price.

Section 2: The Director of Finance is directed to appropriate funds from Fund No. 203-1300-54100 for the purchase authorized in Section 1 of this Resolution.


