**A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO A
PURCHASE AGREEMENT WITH O'REILLY EQUIPMENT FOR THE
PURCHASE OF A 2024 SURE TRAC TILT TRAILER FOR THE
DEPARTMENT OF PUBLIC SERVICE.**

WHEREAS, the Director of Public Service has advised that the City requires a new trailer and has received a quote from O'Reilly Equipment of Newbury, Ohio, to supply a 2024 Sure Trac tilt trailer, as set forth in the quote attached hereto as "Exhibit A".

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Richmond Heights, State of Ohio, that:

Section 1: The Mayor is authorized to enter into a purchase agreement with O'Reilly Equipment for the purchase of a 2024 Sure Trac tilt trailer, as set forth in the quote attached hereto as "Exhibit A", at a cost not to exceed \$20,000.00.

Section 2: The Director of Finance is authorized to utilize funds from Fund No. 401-7150-54500 for the cost of the purchase agreement authorized in Section 1 of this Resolution.

Section 3. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 4: This Resolution shall take effect and be in force form and after the earliest period allowed by law.

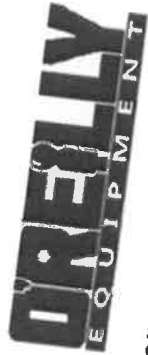
