**A RESOLUTION VOTING FOR A MAYORAL REPRESENTATIVE FOR
THE COUNTY OF CUYAHOGA'S 9-1-1 PROGRAM REVIEW
COMMITTEE; AND DECLARING AN EMERGENCY.**

WHEREAS, the City of Richmond Heights is located within the County of Cuyahoga and is therefore part of Cuyahoga County's 9-1-1 service network;

WHEREAS, Cuyahoga County convenes a 9-1-1 Program Review Committee in accordance with Ohio Revised Code Section 128.06(B);

WHEREAS, Ohio Revised Code Section 128.06(B)(4) specifies that all municipal corporations within Cuyahoga County are entitled to one vote as to the chief executive officer of one municipal corporation who shall represent them on the 9-1-1 Program Review Committee ;

WHEREAS, said representative shall be selected by the majority of the legislative authorities of the municipal corporations in Cuyahoga.

WHEREAS, the Mayor of the City of Euclid, Kristen Holzheimer Gail, has been attending 9-1-1 Program Review Committee meetings in the past and has been recommended by the Cuyahoga County Mayors & Managers Association to fill the municipal representative position on said Committee.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Richmond Heights, State of Ohio, that:

Section 1: City of Euclid, Ohio Mayor Kristen Holzheimer Gail is hereby nominated and voted upon to serve on Cuyahoga County's 9-1-1 Program Review Committee as the representative of all chief executive officers of all municipal corporations within Cuyahoga County.


Section 2: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.


