A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO A PURCHASE AGREEMENT WITH AXON ENTERPRISE, INC. FOR THE PURCHASE OF SEVEN (7) TASERS.

WHEREAS, the Chief of Police has advised that the City requires seven (7) new tasers and has received a quote from Axon Enterprise, Inc. to supply the seven (7) new tasers, with cartridges and battery packs, as set forth in the quote attached hereto as "Exhibit A".

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Richmond Heights, State of Ohio, that:

Section 1: The Mayor is authorized to enter into a purchase agreement with Axon Enterprise, Inc. for the purchase of seven (7) new tasers and accessories, as set forth in the quote attached hereto as "Exhibit A", at a cost not to exceed \$19,000.00.

Section 2: The Director of Finance is authorized to appropriate funds from Fund No. 401-7150-54500 for the cost of the purchase agreement authorized in Section 1 of this Resolution.



Section 4: This Resolution shall take effect and be in force from and after the earliest period allowed by law.



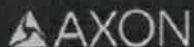
