

RESOLUTION NO.: 77-2024

A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO A PURCHASE AGREEMENT WITH BAKER VEHICLE SYSTEMS, INC. FOR THE PURCHASE OF ONE (1) BALLFIELD GROOMER AT A LOWER PRICE THAN PRICING AVAILABLE UNDER THE OHIO STATE CONTRACT.

WHEREAS, the Recreation Director has advised that a ballfield groomer is necessary for the maintenance of the City's two softball fields and one baseball field to ensure that the infields are properly graded;

WHEREAS, pursuant to the City Charter this Council may authorize expenditures in excess of twenty-five thousand dollars without public advertising, through participation in the cooperative purchasing programs of political subdivisions, including the state of Ohio, and under state law, political subdivisions may purchase from vendors other than those contracting with cooperative purchasing programs, upon equivalent terms, conditions, and specifications, but at a lower price than the pricing available under such programs;

WHEREAS, the City has received a quote from Baker Vehicle Systems, Inc. for one (1) ABI Force Z23SLT Stand on Ballfield Groomer for a lower price than the pricing available under the State of Ohio contract, as set forth in the quote attached hereto as "Exhibit A".

NOW, THEREFORE, Be It Resolved by the Council of the City of Richmond Heights, State of Ohio, that:

Section 1: The Mayor is authorized to enter into an agreement with Baker Vehicle Systems, Inc. for the purchase of one (1) ABI Force Z23SLT Stand on Ballfield Groomer, as set forth in the quote attached hereto as "Exhibit A", at a cost not to exceed \$58,654.00.

Section 2: The Director of Finance is authorized to utilize Fund No. 401-7150-54500 to cover the cost of the purchase authorized in Section 1 of this Resolution.


