A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO A PURCHASE AGREEMENT WITH O'REILLY EQUIPMENT FOR THE PURCHASE OF AN ENCLOSED TRAILER.

WHEREAS, the Recreation Director has advised that the City needs a new event trailer and has received a quote from O'Reilly Equipment to supply a Darkhorse brand enclosed trailer with upgrades, as set forth in the quote attached hereto as "Exhibit A."

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Richmond Heights, State of Ohio, that:

Section 1: The Mayor is authorized to enter into a purchase agreement with O'Reilly Equipment for the purchase of one (1) Darkhorse brand enclosed trailer with upgrades, as set forth in the quote attached hereto as "Exhibit A", at a cost not to exceed \$9,985.00.

Section 2: The Director of Finance is authorized to appropriate funds from Fund No. 401-7150-54500 for the cost of the purchase agreement authorized in Section 1 of this Resolution.

Section 3. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.


Section 4: This Resolution shall take effect and be in force from and after the earliest period allowed by law.
