RESOLUTION CONFIRMING IN PART AND DENYING IN PART THE ACTION
OF THE PLANNING COMMISSION WITH RESPECT TO THE RECOMMENDED
APPROVAL OF A COMMERCIAL RETAIL STORE AT 5182 WILSON MILLS
ROAD

WHEREAS, at its regular meeting on June 12, 2024, the Planning Commission recommended to Council the approval of a wireless phone and smoke shop to be known as "King Wireless & Smoke Shop" (the "Applicant") at 5182 Wilson Mills Road in the Hilltop Plaza;

WHEREAS, the Planning and Zoning Commission of this Council reviewed this matter at its July 9, 2024 meeting but did not make a recommendation to the Council as a whole whether to approve the uses proposed by the Applicant – i.e., wireless phone sales and repair services and the sale of vaping/e-cigarette products (the "Proposed Uses");

WHEREAS, this Council has determined by its passage of Ordinance No. 104-2024 to put in place a moratorium prohibiting sales of vaping/e-cigarette products by new business establishments and those existing establishments in the City not already distributing or selling such products, which moratorium will be in place for a period of six months in order to study the effects of such distribution and sales and to determine whether regulations should be adopted regarding such uses;

WHEREAS, literature from credible sources has made available to the public information regarding the negative effects of vaping/e-cigarette products on persons and the community as a whole which supports the aforesaid moratorium.

NOW, THEREFORE, Be It Resolved by the Council of the City of Richmond Heights, State of Ohio, that:

Section 1: This Council takes the following actions in response to the action of the Planning Commission which recommended to this Council the approval of the Applicant's application for the Proposed Uses:

- a. The proposed use of the premises at 5182 Wilson Mills Road may be used for the sale and repair of wireless phones;
- b. The premises at 5182 Wilson Mills Road shall not be used for the distribution or sale of any vaping/e-cigarette products pending a final decision by this Council whether to adopt legislation regulating the distribution or sale of vaping/e-cigarette products. This action is based upon the reasons set forth in Ordinance No. 104-2024 of this Council.

Section 2: The Clerk is instructed to mail a copy of this Resolution to the Applicant.


