A RESOLUTION AUTHORIZING A CHANGE ORDER TO THE CONTRACT WITH VASCO SPORTS CONTRACTORS FOR THE RENOVATIONS TO THE BASEBALL/SOFTBALL FIELDS AT THE COMMUNITY PARK.

WHEREAS, pursuant to Resolution No. 125-2024, adopted on August 27, 2024, which authorized the Mayor to enter into a contract with Vasco Sports Contractors for baseball/softball fields renovations at the City's Community Park, the City entered into the contract with Vasco Sports Contractors in the amount of \$57,087.00;

WHEREAS, the Recreation Director has advised that additional work not included in the original scope of work in the contract is necessary to excavate the infield lip as detailed in the scope of work set forth in Exhibit A on order to complete the renovations and will increase the cost of the renovations in the amount of \$5,913.00;

WHEREAS, it is necessary to authorize Change Order No. 1 to the Vasco Sports Contractors contract for the baseball/softball fields renovations to increase the contract in the amount of \$5,913.00.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Richmond Heights, State of Ohio, that:

Section 1: The Mayor is authorized to enter into Change Order No. 1 with Vasco Sports Contractors for the baseball/softball fields renovations as set forth in the proposal dated October 10, 2024, a copy of which is attached hereto as Exhibit A, for an increase in the amount of \$5,913.00 to the contract previously authorized;

Section 2: The Director of Finance is authorized to utilize Capital Improvement Fund #401-7150-52100 to cover the cost of the change order authorized in Section 1.



Scope

1. In addition to field regrading, bring in a skid loader to cut down the build up as you transition from infield to outfield. (We will taper the transitions from infield to outfield so that they are less extreme)
 2. Haul excess material off fields and dump at designated dump site provided by city.
 3. Regrade distressed areas to create smooth transition from infield to outfield.
 4. Apply seed and straw blankets to regrow grass in distressed areas.
- * Vasco not responsible for watering or growth of new grass once install is completed.
