A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO A PURCHASE AGREEMENT WITH O'REILLY EQUIPMENT FOR THE PURCHASE OF A NEW TRAILER FOR THE DEPARTMENT OF PUBLIC SERVICE.

WHEREAS, the Director of Public Service has advised that the City needs a new trailer and has received a quote from O'Reilly Equipment to supply a 2025 SureTrac trailer with upgrades, as set forth in the quote attached hereto as "Exhibit A".

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Richmond Heights, State of Ohio, that:

Section 1: The Mayor is authorized to enter into a purchase agreement with O'Reilly Equipment for the purchase of a 2025 SureTrac trailer with upgrades, as set forth in the quote attached hereto as "Exhibit A", at a cost not to exceed \$20,000.00.




