A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO A  
PURCHASE AGREEMENT WITH LA-Z-BOY FURNITURE GALLERIES FOR  
THE PURCHASE OF CHAIRS FOR THE DIVISION OF FIRE.

WHEREAS, the Chief of Fire has advised that the Division requires eight (8) recliner chairs to replace worn-out furniture in the fire station, the purchase of which can be made from a vendor, La-Z-Boy Furniture Galleries, at a total cost not to exceed \$6,159.92, as set forth in the quote attached hereto as "Exhibit A";

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Richmond Heights, State of Ohio, that:

Section 1: The Mayor is authorized to enter into a purchase agreement with La-Z-Boy Furniture Galleries, 7793 Mentor Avenue, Mentor, Ohio 44060, for the purchase of eight (8) "Talladega" recliners for the fire station as set forth in the quote attached hereto as "Exhibit A," at a cost not to exceed \$6,159.92.

Section 2: The Director of Finance is authorized to appropriate funds from Fund No. 233-1300-54500 for the cost of the purchase agreement authorized in Section 1 of this Resolution.

Section 3. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 4: This Resolution shall take effect and be in force from and after the earliest period allowed by law.



