A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO A PURCHASE AGREEMENT WITH NORTHERN FLOORING SPECIALISTS FOR THE PURCHASE AND INSTALLATION OF NEW CARPETING THROUGHOUT CITY HALL UNDER THE OHIO STATE BID CONTRACT.

WHEREAS, pursuant to the City Charter this Council may authorize expenditures in excess of twenty-five thousand dollars without public advertising, through participation in the cooperative purchasing programs of political subdivisions, including the Ohio State Bid Contracts, where contracts have been competitively bid;

WHEREAS, the City has received a quote from Northern Flooring Specialists for new carpeting throughout City Hall under Ohio State Bid Contract No. 800483-2 for the amount set forth in the quote attached hereto as "Exhibit A";

NOW, THEREFORE, Be It Resolved by the Council of the City of Richmond Heights, State of Ohio, that:

Section 1: The Mayor is authorized to enter into a purchase agreement with Northern Flooring Specialists for new carpeting throughout City Hall, as set forth in the quote attached hereto as "Exhibit A", at a cost not to exceed \$37,424.86.

Section 2: The Finance Director is authorized to utilize fund number 401-7150-54650 to cover the cost of the purchase agreement authorized in Section 1 of this Resolution.

Section 3: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 4: This Resolution shall take effect and be in force from and after the earliest period allowed by law.


