A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO A PURCHASE AGREEMENT WITH MORBARK, LLC THROUGH THE SOURCEWELL COOPERATIVE PURCHASING PROGRAM FOR A NEW RAYCO STUMP CUTTER.

WHEREAS, pursuant to the City Charter this Council may authorize expenditures in excess of twenty-five thousand dollars without public advertising, through participation in the cooperative purchasing programs of political subdivisions, including the Sourcewell Cooperative Purchasing Program, through which contracts have been competitively bid;

WHEREAS, the City has obtained a quote from Morbark, LLC to provide a new 2025 Rayco RG37 4 X 4 Super Jr. Stump Cutter with Swing-Out Controls under its Sourcewell contract for the price of \$34,823.30.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Richmond Heights, State of Ohio, that:

Section 1: The Mayor is authorized to enter into a purchase agreement with Morbark, LLC for a new 2025 Rayco RG37 4 X 4 Super Jr. Stump Cutter with Swing-Out Controls as set forth in the quote dated December 2, 2025, a copy of which is attached hereto as Exhibit A, for a total amount not to exceed \$34,823.30;

Section 2: The Director of Finance is authorized to utilize Fund No. 401-7150-54300 to cover the cost of the purchase authorized in Section 1 of this Resolution.

Section 3. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 4: This Resolution shall take effect and be in force from and after the earliest period allowed by law.
