**A RESOLUTION AUTHORIZING THE DIRECTOR OF FINANCE TO PERFORM  
CERTAIN INTERFUND TRANSFERS AND/OR ADVANCES IN COMPLIANCE WITH  
AUDITOR OF STATE BULLETIN 97-003; AND DECLARING AN EMERGENCY.**

WHEREAS, this Resolution is necessary in order to continue the usual daily operations of the municipal government so that the City can properly function and meet its obligations; and

WHEREAS, Auditor of State bulletin 97-003 specifies that interfund transfers and advances should be made by formal resolution of the legislative body of the municipality;

NOW, THEREFORE, Be it Resolved by the Council of the City of Richmond Heights, State of Ohio, that:

Section 1: In order to provide for the continued operation of the City the following interfund transfers and/or advances are approved and authorized to be performed by the Director of Finance:
