**A RESOLUTION ACCEPTING THE BID FOR SECTIONS III AND IIIA OF THE BID SPECIFICATIONS FOR THE RECONSTRUCTION OF SKYLINE DRIVE AND GLEN OVAL AND AUTHORIZING A CONTRACT THEREFOR.**

Whereas, pursuant to legal notice therefor, duly published according to law, sealed bids were received at the office of the Clerk of Council of the City of Richmond Heights for labor and materials for the reconstruction of City streets known as Skyline Drive and Glen Oval in accordance with specifications prepared by the City Engineer and on file in the office of the Clerk of Council; and

Whereas, pursuant thereto, the lowest and best bid received for said labor and materials for Sections III and IIIA of the bid specifications, the watermain loop to Sunset Drive and contingency items thereon, was:

SECTIONS III and IIIA: Tri-Mor Corporation.....\$63,122.00

NOW, THEREFORE, Be It Resolved by the Council of the City of Richmond Heights, State of Ohio, that:

Section 1: The following bid in the total amount of \$63,122.00 for Sections III and IIIA of the City's bid specifications for labor and materials for the watermain loop to Sunset Drive and contingency items thereon, as part of the reconstruction of City streets known as Skyline Drive and Glen Oval, being the lowest and best bid received for such labor and materials be, and the same is hereby, accepted and approved; and the Mayor and Finance Director of the City be, and they are hereby, authorized and directed to execute and enter into on behalf of the City a proper contract for said labor and materials in accordance with the specifications prepared by the City Engineer as follows:

SECTIONS III and IIIA: Tri-Mor Corporation.....\$63,122.00.

Section 2: The Finance Director be, and she is hereby, authorized and directed to appropriate to a proper account a sum sufficient to cover the cost of said contract.

Section 3: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in

compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 4: This Resolution shall take effect and be in force from and after the earliest period allowed by law.
