

RESOLUTION NO.: 98-2007  
INTRODUCED BY: O'TOOLE

**A RESOLUTION ACCEPTING A CERTAIN BID FOR RESIDENTIAL REFUSE COLLECTION AND DISPOSAL; AND AUTHORIZING A CONTRACT THEREFOR; AND DECLARING AN EMERGENCY.**

WHEREAS, pursuant to legal notice therefor, duly published pursuant to law, sealed bids were received at the office of the Clerk of Council of the City of Richmond Heights for sale of services to the City for the collection and disposal of residential refuse in accordance with specifications therefor on file in the office of the Clerk and the Director of Public Service; and

WHEREAS, pursuant thereto, the lowest base bid received for said services was submitted by Republic Services of Ohio Hauling, LLC ("Republic") on Proposal Bid Form A; and

WHEREAS, as part of its bid, Republic has added a fuel surcharge component which will potentially add cost to the City and which the City has analyzed would require diesel fuel costs to rise to \$6.32 per gallon in order for the cost of Republic's services to be comparable in price to the next lowest bidder's bid; and Republic has agreed under the same fuel surcharge formula to credit the City with any diesel fuel charges under \$2.82 per gallon; and

WHEREAS, this Council finds that based upon the bid submitted by Republic in Proposal Bid Form A, and the proposed addendum to Republic's bid and the contract for the service to be delivered pursuant to the bid specifications, Republic is the lowest and best bidder for this proposed contract for residential refuse collection and disposal.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Richmond Heights, State of Ohio, that:

Section 1: The bid of Republic Services of Ohio Hauling, LLC in the amounts set forth on Proposal Bid Form A, a copy of which is attached hereto and incorporated herein as Exhibit A, and with an addendum to the Contract Documents setting forth the parameters of a fuel adjustment surcharge, being the lowest and best bid received for said services is hereby accepted and approved, and the Mayor and Finance Director of the City are hereby authorized and directed to execute and enter into upon behalf of the City the contract for said services for up to a three-year period commencing September 17,

2007 and ending September 16, 2010, with two options for one year each, all in accordance with the specifications in the Bid Documents and subject to the provisions therein.

Section 2: This Council hereby waives any irregularities and/or formalities, if any, in the bid proposal of Republic Services of Ohio Hauling, LLC.

Section 3: The Clerk of Council is hereby authorized and directed to return the checks or bid bonds of unsuccessful bidders.

Section 4: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 5: This Resolution shall take effect and be in force from and after the earliest period allowed by law.
